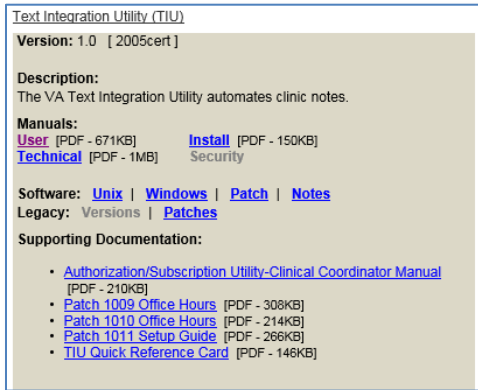

Use the RPMS General Parameter Tool to view or modify these parameters.

- Enter “**^XX**” after logging-in to RPMS and choose ‘*General Parameter Tools [XPAR MENU TOOLS].*’
- After logging-in to RPMS follow the menu path **(start) > EHR > CPRS > IR > XX**. Note: This may not be a valid menu path on your system.
