

Mapping Gender: Shedding Empirical Light on Family Courts' Treatment of Cases Involving Abuse and Alienation

Friday, February 9, 2018 / 2-3:30pm CT

Content: What is really happening in the nation's family courts? This webinar discusses a national empirical study of custody courts' responses to domestic violence, child abuse, and parental alienation claims. While an NIJ-funded 4-year expanded study is ongoing, the results of the original pilot study (240 cases) are now available. The study examined electronically published opinions in custody and visitation cases concerning abuse and parental alienation allegations. It is entirely objective, relying solely on what litigants claimed, what courts found or credited, and how courts ruled. While the pilot study originally sought to examine gender bias in application of parental alienation claims, some stunning additional findings emerged, including the high rates at which mothers lose custody, the stark impact of child abuse allegations, and the gendered impact of parental alienation claims.

The Office of Research Integrity (ORI) is seeking to fund up to four awards of \$150,000 each that will foster innovative research on research integrity. Projects' primary focus should be related to the protection of whistleblowers, prevention of research misconduct, or the furtherance of research integrity efforts in the U.S. and internationally. ORI would like potential awardees to identify ways in which educational programs can encourage the responsible conduct of research (RCR), more specifically: identify risk factors that make misconduct more likely, create evidence base for proactive interventions, build on lessons learned through previous research and the experiences of those who have been involved in guiding research misconduct proceedings, and support the development of tools that can be used to more easily identify research misconduct images and statistical results. Applications are due March 23, 2018, by 6 p.m. ET.

ORI seeks to support conference grants on research integrity. Anticipated grant applications must be designed to provide a forum for discussion and produce tangible outcomes related to at least one of the following themes: responsible conduct of research training, fostering an environment that promotes research integrity, prevention of research misconduct, handling research misconduct allegations, whistleblowing, or other topics clearly linked to research integrity and in compliance with 42 C.F.R. Part 93.

ORI anticipates awarding a total of four grants, up to \$50,000 each. Applications are due March 26, 2018, by 6 p.m. ET.


