The purpose of this management level course is to provide tribal nations with the knowledge, skills and abilities necessary to effectively detect, respond to, manage and mitigate all-hazard threats using a whole community approach. This course will include a practical exercise designed specifically to meet the needs of tribal communities. Training is offered tuition-free through the Rural Domestic Preparedness Consortium (RDPC) and is certified by the US Department of Homeland Security (DHS).

Presenters will guide discussions on managing and operating shelters using fundamental, consistent and flexible principles based on best practices. Tribal cultural protocols and partnerships will be emphasized and incorporated into the discussion.
