The Food Sovereignty Project is able to provide between \$1,000 - \$3,000 to federally recognized Tribes in Idaho, Oregon, and Washington seeking to implement food sovereignty/systems projects and activities to increase food access, food security and sustainability in their communities.

In addition to these awards, through December 31st, 2020, the Food Sovereignty Project can provide technical assistance in the form of data analysis, program evaluation, strategic planning and provide subject matter expertise including nutrition, food systems, food sovereignty, access to food and traditional food topics. ### Activity Examples

- Garden supplies for community or home gardens in the community (such as seeds, soil, tools, plant starts, individual/home gardening kits, etc.)
- Food preparation (value-added processing like canning or smoking/drying food)
- Training in food systems, food safety, food procurement, etc.
- Food distribution program support and outreach
- Community-based assessment support (eg. Community inventory, Food Sovereignty Assessment, etc.)
- Food Sovereignty support including signage for gardens, informational materials, media, etc.

**Funding Restrictions**

Restrictions that must be considered while planning the project and writing the budget are:

- Recipients may not use funds for research
- Recipients may not use funds for clinical care
- Recipients may use funds only for reasonable project purposes, including personnel, travel, supplies, and services

**Funding Agreement**

At the end of your project you will be requested to complete a concluding project report (the template will be provided to you).
